

The Greene County Electoral Board Canvass meeting for the November 2, 2021 election was called to order on Wednesday, **November 3, 2021** at 4:00 p.m. by Chair Ellen Deane at the Registrar's Annex in Stanardsville, VA.

Closed Session

At 4:05 Douglas Miller, Vice Chair, moved to go into closed session to discuss provisional ballots. Roberta Culbertson, Secretary, seconded the motion. The motion was voted on and agreed to. The four observers left the meeting room.

Open Session

At 4:45 the meeting Douglas Miller motioned to reconvene in open session, and Ellen Deane seconded the motion. The four observers returned to the meeting.

The Board voted to approve 3 provisional ballots and 19 were rejected because the provisional voters were not registered to vote in Greene County or they had missed the deadline to register to vote for this election.

*The Board certifies that the Electoral Board of Greene County convened in a closed meeting on November 3, 2021, pursuant to an affirmative vote in accordance with the provisions of the Virginia Freedom of Information Act, and that Section 2.2-3712 of the Code of Virginia which requires a certification by this Board that such closed meeting was conducted in conformity with Virginia law.*

*The Greene County Electoral Board further certifies that, (i) only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act as were identified in the motion covering the closed meeting were heard, discussed, or considered by the Board in the closed meeting.*

The Chair opened all sealed envelopes containing SOR's for the five precincts and the Board checked for complete and correct Statements of Results. The envelopes were resealed for delivery to the Circuit Court judge.

The Chair opened all sealed envelopes containing SOR's for Early Voting, Absentee Voting, and post-election absentee ballots postmarked on or by November 2, 2021 and received by noon on November 5, 2021. The Board checked for complete and correct Statements of Results and tabulated the votes for candidates, including write-ins. All votes from all precinct reports were added to the final tallies. The envelopes were resealed for delivery to the Circuit Court judge.

Douglas Miller moved to certify the election and Roberta Culbertson seconded. The Board voted on the motion. The Greene County November 2, 2021 election was certified at 11:34 a.m.
