The Greene County Electoral Board meeting of **July 6, 2023** was held at the office of the Director of Elections at 32 Stanard Street in Stanardsville, Virginia.

Call to Order

Closed Meeting

The Chair announced the need to enter a closed meeting at 9:01 a.m. in accordance with **Code of Virginia 2.2-3711 Section A** paragraph 8 and 24.2-681 to discuss pending litigation

The Board recessed from Closed Session at 9:26 a.m. in accordance with Code of Virginia 2.2 3712. Board members certified by vote 3-0.

The Board returned to Open Session at 9:27. No action taken.

Director of Elections Report

1. OOE are being contacted regarding training dates. Awaiting final responses of new election workers for scheduled "meet and Greet" sessions with Board members. Potential of 5 new poll workers based on expressed interest. Board members will continue to pursue Party Chairs to encourage volunteers.
2. On motion duly made and seconded, the Board voted 3-0 to accept Director of Elections Report.

2. Correspondence with school district: March 5th election day will be a non-student day. Rooms will be reserved for election purposes only.
3. No response yet by school district re ADA required repair of ramp at Greene County Tech Center.

New Business

1. Board will meet with Greene County Democrats on July 11 at 10 a.m. for purpose of Q&A re Board roles and responsibilities, training of Election officers, need for additional workers, promoting younger age interest for poll workers, early voting, and new legislation, etc.
2. Discussed Virginia Elect sponsored webinar on new legislation scheduled for July 12. Brian and Tom to participate.
3. Next Board meeting date changed to August ¹⁰8, 2023.
4. Confirmed OVI/OVO review of training manuals by Board members and Director of Elections on July 14.
5. The Board reviewed and modified meeting dates through November election Canvass.
6. Early voting training will include focus on multiple ballot awareness.
7. New election workers will be required to observe early voting process and procedures.
8. Discussed impact of recent decision by Gov. Youngkin to withdraw Virginia from multi-state ERIC system used to verify appropriate state residency of individual voters.

The Board returned to Closed Session at 10:12 a.m. for the purpose of completing and reviewing evaluation of Director of Elections with the Director of Elections.



The Board adjourned at 12:14 p.m. Next meeting Date: August 10, 2023 at 9 a.m.


